# Steps for Accident Aftermath

#### **Call 911 & EMS**

You'll need to assess your injuries if possible and the injuries of your passengers. Then call 911 and EMS if anyone is seriously injured. The police will then create an accident report which has details of the incident and a diagram of the accident. Most importantly, swap insurance information with the atfault-party. Be sure to also get the license plate number, name of the other driver, and contact information while you wait for the police to arrive.

# Gather Evidence, Pictures, & Witnesses

This step is extremely important. Take lots of pictures from multiple angles of the accident scene and a video too if possible. Pictures provide proof of property damage to the insurance company. Look around for any traffic or security cameras which may have caught everything on video. Get names and numbers of eyewitnesses.
